Judge Montgomery's reputation as a hard-work, principled and impartial judge has expanded beyond those of us who have appeared in her court. She currently serves as Presiding County Court at Law Judge. Judge Montgomery is in her eighth year of service as the Dallas representative to the Texas Association of County Court Judges (TACCJ); she served an additional four years as an officer of TACCJ. She has also served on the Advisory Board of the Dallas Women Lawyers Association since 2005.

Without exception, Judge Montgomery consistently demonstrates the integrity and judicial temperament essential to public confidence in the judicial system. She received a 4.6 out of 5.0 (92%) in 56 jury trials over four years, for attentiveness, competence, courtesy, demeanor, fairness and patience.

For over 20 years, Judge Montgomery has served the people of Dallas. As Judge for the 95th Judicial District Court, she was one of the three District Court judges with the lowest reversal rate. She continues this impressive record as Judge of County Court-at-Law No. 3 having less than 1/10 of 1% of over 35,000 cases reversed. Judge Montgomery is one of only three Dallas judges to be certified in Civil Jurisprudence by the Texas College for Judicial Studies. She has organized numerous continuing education seminars regarding creditor-consumer rights and professional ethics, and has recently spoken regarding creditor-consumer rights with the Texas Creditor's Bar Association in June, 2017. Judge Montgomery has the top disposition rate for all Dallas County Courts-at-Law for 2017.

Judge Montgomery's success has been neither easy nor overnight. In 2002, she was the lone Democrat elected in any Dallas County-wide race, the first to do so in 16 years. Judge Montgomery has established a record that is rivaled by none in Dallas County. Even so, she needs to be well-funded to discourage any potential opponent for the 2018 general election.
